**CONDITIONS:**

1. Teachers to be provided separate toilet facility
2. Environment should be kept free from mosquitoes breeding.
3. Safe drinking water must be provided to all students and employees.
4. All children must have been vaccinated as per national immunization schedule and guidelines issued by government then and there.
5. All water storage container and specific tanks should be kept tightly closed and maintained clean.
6. Septic tank Air pipe should be covered with mosquito net.
7. Roof top side free from garbage and rain water container.
8. First aid box with necessary medicines should be kept ready for use,
9. No-Smoking awareness, Signage boards should be displayed in the building premises.
10. Doors and windows of the building should be made to open outside easily.
11. Hall buildings should be constructed as per the plan approval enclosed with the application and submitted in this office.
12. No objection certificate should be obtained from this office if any alteration or modification in the existing building and additional building or new building to be constructed school buildings, walls should be white wash once in six months.
13. Maintain fire safety equipment in a condition to use.
14. Kitchen room should be maintained clean and proper drainage system should be constructed.
15. Rain water harvest system should be constructed and maintained.
